I understand that this is a most effective way to promote our cause, as someone who knows nothing or very little about "transvestism", and who <u>does</u> want to learn, will most likely visit the loc library for information. Just deposit the card in the appropriate sectior of the library's card catalog, and consider yourself as having done an important task for your organization.

...I have spoken with Dr. Leslie Borck of the Westchester Self-Help Clearinghouse and who is very anxious to help our Chapter get organized. She has offered to help in however she can, and is presently working with me of finding a meeting place. The site would be somewhere in Westchester Count at a church, community meeting room, etc. Dr. Borck is aware of our "spec needs", and is confident that something can be worked out. To that end I am suggesting that those interested sisters set aside Saturday, January 30 as a tentative meeting date. Please let me know A.S.A.P. if you would attend. Details will follow as soon as they are developed.

...Two suggestions have been made concerning Chapter promotion, and before any action is taken on them, I want your input, as the spending of Treasur \$\$\$ is required. The first suggestion is taking out an ad in the <u>Village</u> <u>Voice</u>, briefly stating that there is an organization for heterosexual crossdressers in the area, and giving Carol's P.O. to contact. Approximat cost would be \$20 - \$30. The second concerns the Chapter purchase of two important books: <u>The TV and His Wife</u>, and <u>Understanding Crossdressing</u>. I would be part of the Chapter's library, to be lent to members and other in terested parties. Cost: \$18. These actions would be a substantial drain for our limited Treasury, but yet they could be very productive and essent al for our Chapter. Your comment, girls. And, while I'm at it, how about you folks who have not yet joined the local Chapter, CHI DELTA MU ???

... As reported in last month's O.S.J., Barbara (NY-217-Mc), has undertaken a very important project which would benefit us all: developing a local "shopping list" of stores where we are welcome. Barbara is doing this at



her own expense (postage, copying, etc.), and she is concentrating in the Queens-Manhattan areas. Publication Policy

... When the first issue of OUR SPECIAL JOY was sent out in October, it was requested that those sisters who were interested in joining the newly-forming local Chapter, CHI DELTA MU (Crossdressers Metro), contribute \$10.00 as an initiation charge. The proceeds are primarily designated for the cost of a meeting facility; hopefully, we will spend those \$ on that soon! However, as you can see from the current and previous month's Treasurer's Report, all expenses have been for postage for the newsletter. These expenses would have been much greater had it not been for Nora Helene (NJ-202-C), who copies the originial proof for us and mails the newsletter to you. Nora Helene is experimenting with two-sided reproduction which would cut our postage cost approximately in half, but this remains to be developed. All other expenses associated with the newsletter are donated by us in our interest to see the Chapter established. O.S.J. has been sent out to 30 + area sisters, including Carol in California and Donna in Chicago. With the intent of preserving an adequate reserve in the Treasury for a meeting, the newsletter will no longer be sent to those sisters who have not joine CHI DELTA MU. Thusfar, less than 1/3rd of the sisters on our mailing list have joined. Through the CLARION published by Carol, those sisters who belong to the National Organization in our area and who have not joined us will be kept up-to-date on our activities. Beginning in January, the CLARION is to be issued monthly, devoted to Chapter activiti on a National basis. It is hoped that those sisters who do not yet belong to CHI DELTA MU will soon be one of us. The newsletter will be sent (one copy). to prospective members and other interested parties.

Legal Considerations

(Ed. note: last month's issue contained a repeat of a DEAR ABBY letter which ended with, "Its against the law in some cities to 'masquerade' (dress), in this manner." I asked our sisters to send in any information they had on this matter. Joyce (NJ-206-M), was kind enough to provide the following piece on this subject. Thanks much, Joyce!)

... "About the legal query you raised on p. 6, there are no state laws in New York, New Jersey, or Connecticut that would apply to crossdressing directly. There are a few 'catch-all' statutes in each state, but the possibility of being charged under them is very remote unless some hot-sh prosecutor really had it in for you. The hazards to us lie in the 'catch all' laws at the municipal level. These are the codes covering everythin from misrepresentation to vagrancy, impersonation, and 'creating a public disturbance'. The problem with them is that, depending on the mood of the attending police officer, many of these codes can be 'stretched' (like pantyhose), to cover most instances where you are dressed in public and have done anything to draw curious or negative attention to yourself - up to and including a traffic ticket. Various types of 'protective letters' have been suggested over the years. Personally, I think the 'protection' offered is far too thin in relation to the difficulty in obtaining them. I suggest we offer a 'bounty' of sorts to the first sister to recruit into CHI DELTA MU a police officer and a lawyer. Then we could set these sisters upon the problem with a reasonable expect tion of success."


