(dressing quarters, motel accommodations for those traveling, etc.). The facility we had been using in New Jersey now has no dressing rooms immediately near the conference room. Also, we are quite confident that the motel's management there really did not welcome us (probably due to the appearance of the motel's name and location in a newspaper article done on us last year and not at our insistance). The service provided us there was not the same as we experience in Westchester, A suggestion was made that since the site in Westchester is super for our needs, with very understanding motel management and staff, that we should remain in Westchester. The overall sentiment, however, was that we should have a New Jersey site. We are booked the second Saturday through December in Westchester, although we can cancel without risk with ample notice given if we do

find a place in New Jersey or if there is not sufficient interest in having a July meeting. The final decision on this matter was that we will continue to meet in Westchester till a suitable meeting place is found in New Jersey. Dorothy had several suggestions as to a site and these will be checked by the location committee.

To establish chapter policy on refreshments, a motion was made and seconded that wine (but not beer), be provided at the meeting and the cost will be a charge to the chapter's Treasury and paid from chapter funds. This motion was approved unopposed.

At the June meeting we will decide if we will meet on July 14th as a regular meeting (Bastille Day, wear red, white & blue). For August 11th, we are planning on a Family Day (1st Annual), Summer Outting to celebrate the chapter's third birthday (see related article in the newsletter). Again, please remember that the June 9th meeting will be in Westchester, and not New Jersey.

No program was conducted during the meeting, but Millie wife of Jane (NJ), had for sale some nice costume jewelry of the '30's period, displayed in our new "living room". We also thank Millie for preparing a delicious salad for us which added greatly to our dinner. Jana, Program Coordinator, has not advised us if the speaker from Mayor Koch's office will attend our June meeting. In any case, it is just great (!!!), to meet with your sisters and their wives/girlfriends and talk.

Although not discussed as a general item for the consideration of the membership, the matter of asking members to complete a questionnaire on crossdressing (and other items), was discussed by the chapter's leadership in executive session. Carol Beecroft had forwarded some 35 copies of this questionnaire to your Editor, with pre-paid return postage, and requested that the questionnaire be

distributed to the membership at the meetings. This research effort is for a Ph.D. candidate in California. The only reason that this matter is in the newsletter is that the questionnaire is somewhat disturbing to myself, as Editor, and to others in the leadership of the chapter; we are considering the pro's and con's of distribution, and will let you know of our decision soon.

Under new business, Edie will purchase "Hi, my name is..." nametags for us. Carole (Ct), suggested that we buy a gift for the motel manager in Westchester, considering the fantastic hospitality we enjoy there. The membership was receptive, but more concern was expressed for the motel's housekeeping and maintenance staff and the work that they have done for us. Renata described how the staff really went out of their way to prepare for our May gathering. It was decided that a pot will be put on the table for donations for the motel's staff to express our appreciation for their effort to make our day as pleasant as it always is there.



Patricia thanked Robin Anne and Linda for bringing their portable tape player. The background music really added to the night's enjoyment. The chapter's 1984-85 Budget, as proposed and printed in the past two newsletters, was adopted by the membership. ...As most of you know, the Susskind program featuring chapter member Eileen (NY) and three other heterosexual crossdressers was aired on May 13th. Eileen found out about the date the Thursday prior to airing (5/10), so we didn't have too much time to notify members, but we did our best through the GAL network and other efforts (one more reason to be in touch with your GAL).

...Your Editor thought that the program was excellent, in spite of Mr. Susskind's obvious state of being unpreprared. Mr. Susskind tried at every opportunity to "stick it" to us, but was properly put in his place in each instance. The only negative aspect was the few seconds that the national organization's address was listed, without much advanced notice.

...The program is to be aired in 40 cities. It was on in LA the third week of April, and according to Carol Beecrof: "We received our first letters today (4/26) from people who saw the David Susskind show. The letters ask for information and I do hope that we will get a lot more members". According to the CHI TRIBUNE (Chicago chapter newsletter), the program was on in that city on April 28th.

Questions & Answers

The following Question and Answer appeared in the May 22, 1984 issue of Woman's Day magazine:

TALKING IT OVER WITH EDA LESHAN

QUESTION

One night when he was fooling around, my husband put on my nylons. Since then, all he thinks about at sexual times is wearing women's underwear. Sometimes when I get ready for bed, I find he has my nightgown on. I've told him how much this upsets me, but he keeps doing it. Is this common? What should I do?

ANSWER

I think your husband is desperately asking for your help. Otherwise, he'd be more secretive about his desires. Such behavior is common enough to have been studied a good deal and to be considered a sign of emotional disturbance. The need to wear women's clothes will probably become more frequent and more intense. This is not a problem that you can work out by yourselves. I suggest that you both consult an expert in sexual problems. Call your local council of social agencies or a mental health clinic for advice.

My opinion, for what it is worth:

Variety can be the spice of life. Sex therapists advise, when the ZING seems to have gone out of a couple's sex life, to try for some variety such as a change of scene, a change of time, sexually stimulating clothes, music, perfume, etc. Of course, if it upsets one of the partners, as in this case, the behavior should be modified. Actually, in this case, it sounds as though the husband's behavior is beyond merely trying for variety. The danger to avoid is fetishism, where some item is necessary for sexual satisfaction and may even replace the partner as the object of sexual attention. Eda LeShan's advice is good, but, for the sake of the happiness of the couple involved, we hope that they find a really knowledgeable and compassionate "expert".

Looking Forward

"FEMINA OPENS TO CROSSDRESSERS' DELIGHT"

-----Albany, New York, June 16, 1988 A.P. Special Report

After almost a year-long court battle a group of heterosexual crossdressers have received approval of the government to open their country resort. Called "Femina", the spacious 200 room facility located in upstate New York in a secluded valley east of the Hudson River will be owned and operated by Betty Klemp and her (or if you prefer his), wife Helen, formerly of New York City. Betty is a member of the TRI-ESS Sorority, or the Society for the Second Self, an organization dedicated to assisting the male heterosexual crossdresser or transvestite in overcoming fears and educating the general public on the crossdressing experience and lifestyle.

Legal problems developed for this group shortly after Betty and Helen won a New York Lottery prize of \$23 million last year and announced their plans to purchase the resort. formerly called "Shadyside" and closed for the past three years. At first the local citizens were up in arms about having a group of men in dresses and skirts in the local community. Their fears were soon dispelled when, at a Town Meeting, the goals and objectives of TRI-ESS were explained to them and the impact of "Femina" on the local economy with new jobs, purchasing, and other benefits to the Town's treasury were demonstrated. "They really appreciated us after one week of members spending money in the Town", related Patricia Gallagher one of the group's leaders. "We used only silver dollars, and after a few days the townsfolk firmly took notice of our purchasing power" related Ms. Gallagher.

"The residents soon became our biggest supporters", said Betty. Problems with State zoning regulations continued, and legal proceedings were undertaken against Betty and Helen's dream project. After several months of negotiations, an out-of-court settlement was reached when Betty and Helen agreed to install a men's room in the facility. "An unnecessary expense, but if it will satisfy the bureaucrats,





we'll do it", said Betty. "Helen has suggested that we could use the urinals the help the plant nursery we want to start.

Opening cermonies were held last Saturday, with the dedication of the resort keynoted by the TRI—ESS national leader, Carol Beecroft. Cutting the pink ribbon at the resort's entrance, Ms. Beecroft said: "This is certainly a milestone in the development of our organization. A very positive step, and I'm sure that in years to come this event will be looked upon as a turning point for all of us". Ms. Beecroft was wildly cheered by the some 800 Sorority members, wives, girlfriends and others. The metropolitan New York chapter, CHI DELTA MU, chartered 36 buses to transport members for the event.

Perhaps the most significant development at the cermony came when Betty announced that she and Helen had purchased 4000 acres surrounding Femina and will offer to members an unbelieveable 6% mortgage for lot purchases after the property is subdivided.

"We are going to create a community here, a good community for our families in which to live, work and grow", said Helen. Mary Jane Moran has already put in her bid for 2 acres near the resort to build a home and an adjacent office to publish and ship the chapter's weekly newspaper, OUR SPECIAL JOY. "I feel like a 19th century pioneeress, crossing the praire in a covered wagon and, of course, my praire skirt", said Mary Jane.

The group encompases all types of people, with all kinds of backgrounds: teachers, plumbers, lawyers, doctors, you name it. "We are ready to blaze a new frontier", continued Mary Jane.

The nearby town's mayor recently said: "Once you get to know them, they are very nice people. Besides, their dollars are just as green as anyone else's". This has already been demonstrated by the opening of new dress shops, beauty parlors, and others formerly vacant.

Charter member Nora Helene summed up the group's reaction to these developments: "I've always felt that we are limited by those limits we place upon ourselves. Seven years ago we had nothing, look at what we have now! Think about what we will have in the years to come!!".

Dear Mr. Susskind,

You are to be commended for allowing four heterosexual cross-dressers to tell their stories on your May 13th television program. Had I seen such a program 35 or 40 years ago, I could have saved myself from as many years of self-doubt, guilt, dishonesty and frustration. For, you see, I am a cross-dresser, too. In my case, however, I am still "in the closet."

When I was about four years old, my mother and her visiting girlfriend conspired to have me and the girlfriend's daughter exchange clothes and pose for snapshots. I cannot say that I remember the incident, but I remember all too painfully the teasing and derision heaped upon me by my brother and cousins every time the family album was brought out of the dining room buffet drawer. My humiliation was so great that one day I destroyed the photographs. Whether or not this incident imprinted the idea of cross-dressing on my brain, I do not know. Maybe the doctors of Psychology have an explanation for it, because how could a practice which brought me so much shame and humiliation now be so enjoyable to me?

Although I've had the desire to cross-dress ever since I can remember, only as recently as three years ago, at age 53, did I start to acquire a feminine wardrobe of my own. I have been out in public - in restaurants and stores - as Edith Marie only five times and I "passed" as a woman on 4.9 out of the 5 excursions.

Your guests have "come out of the closet" to the extent that their close loved ones know about their strange hobby. I believe by situation is more typical in that my wife does not know and I am afraid that, if she should find out, our marriage would be wrecked. Aside from the desire to explore the feminine side of my personality, I believe I am quite normal and a solid citizen in society. I am a professional, having earned both Bachelor and Master's degrees and State registration and I am active in church and community affairs. One thing I am NOT is homosexual.

If you should ever decide to do a "follow-up" on the subject of heterosexual cross-dressing, I would be very happy to participate in such a program.
