A Legend in Her Own Mind. ... GERRI C.



"Who is Sylvia? What is she, That all our swains commend her? Holy, fair and wise is she; the heaven such grace did lend her, That she might admired be."

Two Gentlemen of Verona, Act IV, Scene 2

William Shakespeare wrote over four hundred years ago about an ideal feminine image personified by his stage character of Sylvia. The actor who portrayed Sylvia required a consistency of physical behavior and a mental picture of her personality and background to make the role credible to the audience in the Globe Theatre. It is worthy of note that all of Shakespeare's heroines were played by boys pretending to be girls.

If you expect to present a believable image of femininity in public, more than mere techniques of makeup, hair styling, and costuming are needed to complete the picture. In most social occasions, a previously prepared story of the putative female's past will add to the genuineness. A bystander might wonder, "Who is she? Is she married, and does she have children? Where did she come from and what is her education? What are her hobbies and her outside interests? What does she do for a living, and what is her social status?" Such curiosity, unless satisfied with readily available information, might raise doubts about the validity of this person as presented, despite having the right voice, mannerisms, and poise. Like the actor, the cross-dresser should provide motivation for the character she is portraying. The depth of emotional identification with your feminine self is up to each individual; here we describe only its public aspects.

To perfect the feminine image, one should prepare a formal life story, similar to the resumé presented upon applying for a job. Such personal information should be readily available if and when the occasion requires it. This exercise will more firmly implant the feminine role in our own minds; a positive mental attitude will go a long way in enhancing the credibility of a womanly likeness. A cross-dresser in public must seem real, and not appear to act as a charactature. Motivation and "method acting" are as essential to fulfill our feminine role-playing as they are to the modern actor, or to the Elizabethan predecessors.

Another example of role-playing carries the fictional biography of the role a step further--the professional spy is shielded from detection by living the "legend" or cover story of his false identity. He must be completely believable in order to blend unobtrusively into the society in which he wishes to operate without detection. If he is caught, his cover must be maintained at all costs to preserve his real identity or country of origin. A well fabricated "legend" is a basic tool of spy tradecraft, which is built around the life story of a fictional person whose life style is appropriate, consistent, and unremarkable. The spy's "legend" is conceived as a role model, to be worn like a suit of clothing by the agent. there must not be any false note by the projected image that will invite close scrutiny. The spy must whole-heartedly live his role in a manner far more intense and serious than does the actor.

The real spy, unlike the cinematic James Bond (whose real identity is always known by the bad guys and whose cover stories are not credible), shuns the high profile and seeks to merge into normal life. This is a situation not entirely unknown to the cross-dresser who goes in public.

If we can convince ourselves of our mental picture of femininity, we can better convince others. We should follow the advice of the philosopher René Descartes, who wrote, "Cogito, ergo sum."--"I think, therefore I am." The woman within may have a fantasy image, but the public woman must have credibility. This requires a "legend" acceptable to the society at large. You may wish to use the resumé form on the next page as a guide in constructing your own "legend".

October Nights/Cape Cod Delights

It's P-town time again with the arrival of the 12th Annual Fantasia Fair, to be held October 17-26, 1986. The details about this fabulous nine day cornucopia of cross-dressing are described elsewhere in this issue. One should note, however, that there are a number of new features and activities for this year's edition of the Outreach Institute annual event.

Upon arrival in Provincetown, each participant will receive a packet of Fantasia Fair facts in the form of an introductory booklet. Also, the newly-minted *femme fatale* will be given individualized analysis of figure, face, hair, skin, and other aspects designed to enhance her image as part of the Fashion Beauty Fair.

Each fairgoer will stay at one of several inns or hotels, organized to provide a "home away from home" with a house hostess. Informal social sessions and impromptu parties will be the order of the day at each residence. It is hoped that each of these hotels will provide enough clothes hangers, closet space, parking facilities, sufficient lighting, and plenty of full length mirrors to satisfy the most frenetic cross-dresser.

Besides the seminars on legal, psychological, and sociological aspects of gender juxtaposition, there will be additional sessions entitled "On the Town" and "Life Styles". These will be panel discussions conducted by persons experienced in living as women in public. The social scene will be enlivened by the "Ladies' Night"; an exercise in womanly role-playing designed to polish social skills. There will also be a cocktail party to give recognition to the movers and shakers of our community. Somehow these events will be squeezed in between the Participants' Dinner, the Town and Gown Supper, the Fashion Show, the Fantasia Fair Follies, the Awards Banquet, and the Fantasy Ball. Whew!

Perhaps the most attractive feature of the Fair is its site, which has been a remarkably friendly and supportive host for the past eleven seasons. The historic Cape Cod port of Provincetown ("P-Town" to the old-timers) has an interesting population of merchants and mariners. One can observe the frolics of a gam of whales or view the scene from the impressive tower. The many delightful shops and restaurants (specializing in seafood with a Portuguese flavor) may lure the visitor away from the Fair's more formal activities, but one must be prepared for the somewhat erratic Cape weather. All in all, the Fair consists of days of seriousness and satisfaction; frenetic activity and frivolous fun...Enjoy!

HOW TO REGISTER

(1) Complete the registration form provided in this brochure.

(a) Be sure to indicate clearly the exact dates you wish to participate and your choice of accommodations.

(b) Please list your mailing address exactly as you wish to receive all correspondence.

(c) A telephone number is not mandatory but may be helpful in case of program changes or other necessary communications.

(2) Send completed registration form with a minimum deposit of \$200 per person or \$350 per couple (check or money order) to: FANTASIA FAIR LTD

(a) All money orders and checks must be payable in U.S. currency. (No personal checks will be accepted after 45 days prior to the start of the Fair.)

(b) Make all money orders and checks payable to Fantasia Fair Ltd.

(c) Final payment to be made to Fantasia Fair Ltd. by certified bank check or money order only, unless sent 45 days prior to the start of the Fair.

(d) To facilitate your payment to Fantasia Fair Ltd., we offer a charge account service including either a valid VISA or MASTERCARD. You may charge your balance of Fantasia Fair Ltd. costs, excepting the initial deposit. Please indicate clearly your VISA/MASTERCARD

number.

(3) Upon receipt of your registration and deposit a receipt of space confirmation will be mailed to you.

(4) A statement of your balance due will be sent to you shortly after you register. Please note that except in the case of late registration, all accounts must be paid in full no later than 30 days prior to the start of the Fair. Your cooperation with this will be appreciated.

(5) As soon as your registration is processed, newsletter and other material will be sent to you from time to time in order to help you prepare for Fantasia Fair.

CONDITIONS FOR PARTICIPATION

In the conditions the term "Institute" refers to Fantasia Fair Ltd. and the term "participants refers to the person signing the registration form.

(1) Registrations will be accepted from all persons who have reached their 18th birthday prior to 17 October 1986.

(2) Fantasia Fair participants are expected to maintain certain minimum standards of attire and deportment that are appropriate to individuals of any respectable group. If a participant's behavior continues to be inappropriate, the Institute reserves the right to terminate that participant's stay, refunding to the participant 50% of the charges for the time remaining at the point of termination.

(3) The deposit of \$200/person or \$350/couple shall be treated as partial payment of the total due, as stated in this brochure and by agreement between the Institute and participant.

(4) All participants who have their accounts paid in full prior to July 1, 1986 will receive a discount of 5% of the total cost of the selected plan (exclusive of seminars and workshops).

(5) Except in cases of late registration, all payments are due no later than 45 days prior to the start of each Fair. If payments are delinquent after that time, unless special arrangements are made, the Institute reserves the right to cancel the reservation as per No. 6b below.

(6) If a registration is cancelled, the Institute will refund to the participant all monies paid LESS the following amounts:

(a) Cancellation 2 months prior to the start of each

Fair: \$60.00.

(b) Cancellation 1 month prior to the start of each Fair. 65% of total.



When we send our sisters a free copy of OUR SORORITY we hope that each sister will note that there is a group in her area which will welcome her as a new sister if she wishes to leave her closet to find a happier environment with many new friends, who share in the same uncomplicated joys of dressing. We regret that such groups are not available everywhere in the Country. In time, perhaps

Why do we do this?

In the 1960's when Virginia Prince founded the FPE as <u>the</u> first national crossdresssing sorority for heterosexual transvestites, there started a chain of chapters across the country which numbered over twenty. Each local chapter was pretty much like the other with "uncomplicated" transvestites growing to realize perhaps how really complicated they were, and watching others as they came and went. But, FPE was a secret society, as were so many other groups which came and went. The poor TV who found out by accident (in a card catalogue in a library, or by word of mouth) that a group existed often was disappointed to learn that group was a thousand miles away. When she wrote to that group, she heard nothing about how to reach a group nearby her, and often as not very little about how to reach a different chapter of her own group. The word was that these other groups were "too open" or they catered to the <u>wrong kind</u>.

Perhaps I am the "wrong kind" and I am <u>too open</u>, because as a human I recognize how very fickle chance is and I know that but for the Grace of God I would never have found my sisters if it had not been for a chapter leader who wrote me, against policy, to advise me of a different group in my area. She cared, and I do to! That is part of the reason

After <u>thirty</u> years of meeting my sisters I have found the good, the bad, and the beautiful souls in every <u>kind</u>. When I read the third issue of *Transvestia* (which most think is the first) I had already met hundreds of sisters all over the country, who came up to me when I stepped from the stage to shyly confess, often in near tears, that they had never met another sister. They were so sad that there was no one else to share their secret joys. When they saw me, they <u>assumed</u> that because I was a female impersonator, <u>I was gay</u>, that I was not their <u>kind</u>. But, yet they had to share ... I didn't think of myself as gay, I was a professional entertainer, and it was a job that I liked. Being gay, was just a way, that I saw <u>others</u> live as their choice of lifestyle. When you run away from home at fourteen you learn a great deal about others. I learned, with quiet little talks, that all my sisters (whether straight, transsexual, or gay) were all very much alike when it came to their secret joys of the woman within. That is part of the reason

When groups formed within the Washington area I went to each: Academy Awards, FPE (RHO), the International Alliance of Male Feminism, and Tri-Ess. And when it was all said and done each group was much the same... That is another reason

What we wanted to do was to give our sisters a better place to go out in public than a lonely dangerous street, or try to "pass" in a Mall when they are alone with only the consent of their uncritical self and a mirror. Perhaps a group can help a person to grow without such trauma and risk. A place where you can go, suitcase in hand, to dress and learn those skills you may need before you venture out into the real world. Or perhaps where you may not need to wander because you have found those who understand you.

These are some of the reasons why we take time to recommend events and groups to our sisters. Perhaps it is because we care for and love you







In example, I can remember that she believed that she should dress from success in suits made by Schiaperelli or King,"...who are women, and therefore know what is correct for a smart woman to wear." And then to my utter amazement she took me to buy my own clothes from Saks Fifth Avenue where my mother had bought those sissy boys clothes that I hated so much. There, in the girl's shop she announced: "I will tell you what you need. You will select them for yourself and then you will tell me why you picked what you did so that I can see for myself how you think. But, I must warn you that when you select something you will wear it even if it foolish to others until it wears out, no matter how sick you feel about your choice. This is the only way that you can acquire taste."

When she thought that I needed comforting she had Franciszka, her Polish housekeeper, who viewed the whole matter of my girlish life as a joke noting with a knowledgeable smile that she knew of a boy just like me who grew up to be a great soldier. She then promptly took me out and had my ears pierced! To her the house was divided into two parts; the front and the upstairs belonged to the "Empress" but the rest was Poland! Therefore, the arrangement was that when I was in "Germany" I was Miss Betty Ann, and when I was in "Poland" I was <u>Beta</u>. This was an awful pun, which suited her delight. And it was Franciszka who determined what to do with a little boy, whom everybody thought was a girl, when school started. Give the child to the nuns. I do not know how it was arranged, my great aunt would only shrug when I asked her many years later and Franciszka laughed....

One day 1 asked my great aunt what the difference was between a man and a woman. "Remember this. A man may conquer with his strength, but a woman rules with her head and her heart through the art of many little kindnesses."

I can still remember that moment when I realized that although she, my mother, and Franciezka were all very different, they were all women because they knew the "art of many little kindnesses".



Fashion and Beauty Tips: BETTY ANN LIND

BEARD COVER



Attached to the shaft of each human hair is a tiny muscle which contracts to hot water and thereby brings the hair erect so that a barber can give a close shave. This process opens the pores, so after shaving use cool water to wash the face. Next use a light moisturizer lotion to prepare the face for make-up. WHENEVER you use a lotion, make-up or any skin product remember that the most popular "drug store" Name Brands are: 1) less expensive, 2) subjected to generally tougher quality control checks than "expensive brands" (due to the company's greater mass market exposure to suit), and 3) are usually chemical clones of the "expensive brand".

Regardless of <u>race</u>, there are two basic under skin pigmentation tones; 1) <u>rose-pink</u> with a bluish pigmentation and 2) <u>peach-pink</u> with a yellowish pigmentation. Beard, hair and eye color all can be divided by this same color tone factor. The <u>Eight Minute Make-Over</u> and <u>Color Me Beautiful</u> are based upon this secret discovered by Robert Dorr in 1950. Since then we have learned that a pastel green will neutralize rose-pink pigmentation and pastel purple will do the same to peach-pink. Esteè Lauder makes a line of undercover products that are excellent. A light appropriate color application under your foundation can cut beard shadow. Since most of us have the rose-pink pigmentation, Hollywood make-up artists (in trying to cover the male beard) have discovered that an orange-red blush tone usually called "sunburn" by various manufacturers can effectively conceal most heavy beards. The use of white cover can actually bring out a BLUE beard.

Once you have applied the "color" to conceal the beard the next step is to select a foundation to neutralize that color so that the beard area has the same general hue as the face. There is a line of concealer products offered by several manufacturers (e.g.: Recover, Cover Mark, Diminish) which are designed to: a) "breathe" in hot weather, b) be waterproof, and c) cover scars, tattoos, and other serious skin blemish problems. Usually the terms "rose" and "pink" mean the product will blend into a rose-pink pigmented skin, while the others ("light", "medium", and brunette") will complement the peach-pink skin pigmentation. Rose-pink on peach-pink turns it mask orange toned; peach-pink on rose-pink turns the skin to a white paste mask like shade.

Use the concealer product over the color applied to the beard area. <u>Patin, don't rub off</u>. Practice until the blend with your natural skin is right. (Use daylight bulbs, and work towards using just enough cover to conceal.) Then apply a regular foundation and your make-up.
