### A COURTESY REMINDER . . . . . .

Because of a number of problems which have developed during the past year, when we have been fortunate enough to be able to meet in private homes, a few reminders appear to be in order:

Balance on hand. December 31st:

- l. The meeting starting time is always clearly indicated. Do not arrive at the home before then, as your hostess has her own schecule to meet. She must complete her preparations for refreshments, perhaps make arrangements regarding children, get herself changed and ready, etc. She does not have time to greet and entertain "early arrivals" in the afternoon or early evening, or have facilities available to allow "changing" before the time the meeting is scheduled to start. If you arrive early in the area, go out to eat or go shopping; your hostess is not ready for you!
- 2. Your hostess spends quite a lot of time in preparing special refreshments and getting her home ready. She bases her preparations on the number of members who plan to attend, from the post cards returned to her. If you plan on attending the meeting, the lost card should be mailed in sufficient time to guarantee receipt no less than one week before the meeting. If your plans change after the card is mailed, a telephone call to the hostess should be made to alert her that you cannot be there. Although we hope all members will attend a home meeting, arriving at the home without prior notification by post card (or a telephone call, before the day of the meeting) can cause last-minute problems for the hostess.
- 3. Out-of-town members should not plan to stay overnight at the home of the hostess. In many cases there is simply not enough space available, it could cause problems if there are children living at home, or it is just plain inconvenient! There are motels available in every area where we hold a home meeting; please make prior arrangements if you expect an overnight stay.

I believe we all want to hold meetings in homes as often as possible, but unless we all display a little courtesy these homes will not be made available to us. How about it?

## CHI CHAPTER DUES . . . . . .

As reported in last month's newsletter, you Chapter dues are now payable.
