Not even at Club 22 or Palms where at best we're only welcome in small groups and certainly not in the mainstream.
Please help keep the Queen Mary safe for all of us. If we lose this valuable resource for our community, we might once again become divided into disconnected factions. We've come too far in the past couple of years to let that happen now.

( $k m r$ ) -- After considerable discussion about the image problems created by the previous leadership of Alpha Chapter, those members attending the August 4 meeting voted to form a new Tri-Ess chapter, rather than expend energy correcting past difficulties.
The new chapter, to be chartered as Lambda Alpha, is in the process of contacting all Tri-Ess members in the region to inform them of the new organization. It is belleved that many members had abandoned Alpha because of problems with some of the chapter's past leaders. For this reason, Lambda Alpha will also attempt to contact many of the inactive Tri-Ess members in the Los Angeles metropolitan area as well.
Lambda Alpha will hold its first meeting September 8, under the guidance of interim leaders Janyne Cresap and Sharon Anderson. It will then adopt Alpha Chapter's old schedule of meeting on the first Saturday of the month.
Tri-Ess National Director Carol Beecroft, who was present at the vote establishing the new chapter, said that unless Alpha reestablishes itself within a three month period, its charter would be revoked.

## GENETIC FEMALE ARRESTED FOR UIOLGTING CITY. RESTROOM LAU

(AP) -- A genetic female has been arrested in Houston for violation of a city ordinance prohibiting the use of restrooms designated for the opposite sex.
Denise Wells, who was attending a George Strait concert at the Summit Arena on July 8, entered the men's room after the line at the women's room proved unbearably long. When she emerged, she was stopped by a police officer, given a $\$ 200$ fine, and escorted out of the arena, abandoning the third row seat for which she hasd paid a ticket broker $\$ 125$.
Wells' sister, Valerie Davenport, who is also her lawyer, says she has recelved nearly 60 offers from women willing to testify on her behalf, saying that they, too, have sought relief in the past by using the 'men's facilities. Davenport says she plans to argue "necessity as our first line of defense", and will also argue that her sister did not, in fact, violate the ordinance.
Davenport's argument is based upon the specific wording of Houston City Ordinance 72-904, which states "It shall be unlawful for any person to knowingly and intentionally enter any public restroom designated for the exclusive use of the sex opposite to such person's sex... in a manner calculated to cause a disturbance." Wells claims she "wasn't disruptive", and that she had followed another woman (who was escorted by her male date) into the men's room, cupped her hands like blinders around her eyes as she passed the urinals and entered stalls. She says that the other woman did likewise, and that she was "embarrassed to death". The status of the case of the other woman, who was also cited and escorted from the building, was not available.
Since 1985, Houston's plumbing codes for large gathering places have required additional "sanitary facilities" for women, correcting earlier problems that resulted from theories that more men than women attended sporting events and conventions. However, the Summit, built in 1975, is not subject to retrofit, and according to Summit operations manager Henry Thomas, men's restrooms redesignated as women's were overcrowded as well on the night of the incident. "We have no place to put them" when the facilities are swamped, Thomas sald.
Because Wells' case is based upon the specific wording of the 1972 ordinance, dealing with intent, transgender organizations both regionally and nationally are watching the outcome with great interest.

## DAD MAKES DAUGHTER LIVE AS A BOY

("Sun") -- A youngster who was born with both male and female sex organs was subjected to a life of abuse from a drunken father who insisted on having a son. サikki Summers, now a pretty 24-year-old woman, was ralsed as Shaun because her father refused to listen to experts who urged him to watch the hermaphrodite child to see which sex she most behaved like. Jim Summers was so determined to have a boy that he forced Shaun to undergo shock treatments and hormone therapy, and strapped down his breasts when they began to develop The confused kid attended school dressed as a boy where he was taunted because of his feminine traits. "I avoided games because I didn't like changing in front of the other boys. I knew I didn't look the same," recalls Nikki, who is presently saving money to remove what remains of her male genitals.
Shaun tried to act as masculine as possible around the house, enduring visits to a speech therapist in an attempt to lower his girlish voice, dally hormone pills coupled with tight t-shirts to bind his breasts, and shock therapy from a psychologist while being forced to view gay porn movies.
Nikki's nightmare finally ended at the age of 14 when her father died. She now lives with her bodybuilder boyfriend and works as a factory quality control worker.

## FI HAUNTED BY MARILYN'S GHOST

("Sun") -- Female 1 mpersonator Jimmy James, whose exact likeness to Marilyn Monroe when snuggled into a tight sexy dress won him the starring role in a new television special about her life, says he's haunted by her ghost.
While filming the special at the Roosevelt Hotel in Hollywood, where Marilyn often stayed, James says he was visited by her ghost while he was putting on his makeup in preparation for a scene in which the image of the late blonde star was to appear in one of her old dressing-room mirrors. The TV crew in the basement found that every time they zoomed in on the mirror, the hotel's fire alarms went off and the elevators stopped running, trapping jimmy on the eighth-floor... and, "strangest of all, when they took (the alarm) of $f$ the wall, they found (1t) was broken. It should have been incapable of ringing at all," says hotel executive Kelly Greene.
James says the hotel incident is just one of many unusual happenings connected with his eight-year-ald Marilyn act. Once, in Dallas, Joe DiMaggio, the former husband of the famous legend, appeared on Jimmy's television screen as he was leaving the room to go on stage. Her famous 1962 rendition of "Happy Birthday" at President John F. Kennedy's birthday bash appeared on his home TV on another occasion, while he was reading about her life.
Nonetheless, Jimmy says that singing, acting, and wiggling like Marilyn makes him feel like the reincarnation of the sex goddess, even though he was only three years old when she died.

("National Examiner") -- A Chinese farmer who has walked around naked for the past 24 years was finally convinced by his doctors to wear clothes... and chose a miniskirt and halter top!
If Jinya, who suffers from "clothesphobia", actually began to shake and break out in a sweat at the mere suggestion of dressing. Doctors say the rare condition sometimes causes "seizures and convulsions if the patient is made to dress before be's ready.
2r. Yang Kelian. the psychiatrist who spent 13 years zounseling the paranold farmer, says L 1 is physically itt and has a strong heart. He says the turning point in his patient's therapy came when he persuaded li that it was unacceptable to attend National Day celebration in the nearby village in the buff.
"He wanted to attend the celebration so badly that he agreed to try wearing clothes," Dr. Kelian said. "But oniy a miniskirt and a halter top." The doctor claims that because the skirt was lighter on Li's body than trousers, there was sufficient air circulation to keep the clothing from bothering him. Kelian calls it "a major breaikthrough" in hi@ fatient's counseling.

## SEX-CHANGE WOMAN PREGNANT

("Globe") -- A woman who underwent sex-change surgery 13 years ago now claims she has been artifically inseminated and is pregnant.
43-year-old Erika White, whose first name was Ted before her 1977 operation, told a nationwide cable TV audience on WWOR's "9 Broadcast Plaza" that her husband's sperm was used to 1 mpregnate a donated egg, which was then surgically implanted in her abdominal wall. She claims she was approached by a team of doctors last year as a candidate for the unprecedented operation because the surgeon who performed her
sex-change operation discovered she was born with "an ovary and a half"
White told television viewers the experimental operation was underwritten by the prestigious Chubb Medical Foundation, but a spokesman denies this. The doctor she identified as having performed the artificial insemination also denies any involvement Even the self-proclaimed mother-to-be's estranged husband, Tony, claims no knowledge of his sperm being used: "If she was 1mpregnated, it wasn't by me For her part, Erika says she's packed 37 pounds onto her already stout 5'7", 144-pound frame during the first seven months of her pregnancy, and claims to be suffering "morning sickness, cramps, and backaches"

## GAY MONK PRAYS FOR FEMALE BODY

("Sun") -- A gay monk in Australia has traded his brown robe for a colorful skirt and blouse, and is now praying to God for a sex change.
Brother Paul James, who now answers to the name Janine Rose, says that eight years in the monastery has only made his intense feelings to be a woman stronger knew I was gay when I entered," the mixed-up monk says. "I thought joining a religious order was the answer." But the Society of St. Francis monastery turned out to be full of homosexuals, and while Paul tried to abstain, he became overwhelmed by the temptation.
While church officials paid for psychotherapy in an attempt to end his overpowering urge to be a woman, he ultimately decided.to leave the order and face the real world as Janine.
But he hasn't yet come up with the cash needed for his operation. Says the crossdressing ex-monk, "I pray to God every night for help... I plead that he will let me become a woman.

## FROM GAL TO GUY; TO GAL; TO GUY

("National Enquirer") -- Jerry Sousa was born a woman and since then has had not one but THREE sex
changes!
"My life must seem bizarre to many people," admits the 51-year-old. Jerri, as she was then known, married a handsome serviceman and had two daughters with him. Then, deciding her marriage was a total lie, she divorced, bas a series of affairs with other women and men... before having a third child in 1969. When her son was six months old, she started hormone treatments, grew a beard, had her first operation and changed her name to Jerry.
In October 1981, though, after a relationship with a woman Jerry had hoped to marry broke up, he began wondering if he had done the right thing twelve years earlier: "I stared at my hairy body in the bathroom mirror and asked myself 'What have I done?'"
Sousa began dressing as a woman again, stopped taking male hormones, underwent electrolysis and went on a waiting list for breast 1 mplants.
But in April 1988, after her son died from a kidney problem, Jerri, convinced that her son would have recelved better care if she had been a man, decided she would be more comfortable living as a male. A couple of months ago, she legally changed her name back to Jerry and restarted bi-weekly male hormone injections, which has caused a regrowth of facial hair.
Sousa's doctors say he's the only documented case of someone who has completely changed sexual identity three times for substantial periods of his life, but this time he claims "I am a man for keeps.

## STANDARDS DF CARE

One topic which is often questioned by transgendered people are the "Harry Benjamin Standards." While transsexuals are often more familiar with them than are crossdressers, these standards apply to all persons with gender discomfort. Just what are these standards and how are they generally used?
First, some history. More than a decade ago,
clinicians who worked with transgendered persons formed the Harry Benjamin International Gender Dysphoria Association (HBIGDA). In the late 1970 s members of this professional organization decided that, due to the invasive nature of the treatment of transsexualism, a formalized set of minimal guidelines were necessary Such guidelines would provide uniform criteria to guide clinicians working with transgendered persons. The initial Standards of Care were published in 1980. They are concerned with persons who are diagnosed as gender. dysphoric. The "Diagnostic and Statistical Manual of Mental Disorders" published by the American Psychiatric Association (DSM-III-R) has several categories of gender dysphoria but the ones most closely connected with these standards are those describing transsexualism.
The Standards of Care are based upon significant clinical experience with transsexual clients. They are guidelines describing who should recommend hormone treatment and genital reassignment surgery. In addition, they describe under what conditions such recommendations should be made. It is here that many people object to the time limits. They feel that "my situation is different" from all the other persons who identify as transsexual, so exceptions should be made. Usually this means shortening the time for "the real life test" and/or the recommendation for hormone therapy
I have told countless clients, "It is not possible to be objective about your own situation." The purposes of the Standards of Care and the services of a clinician are to prevent a person from taking irrevocable steps which they can regret later. The most difficult part of the whole process is making the diagnosis of transsexual. It cannot be made quickly even though the person emphatically states that they are transsexual. I am sure many of you have heard the "horror storles" of persons who have obtained genital reassignment surgery and then discovered to their dismay that it was not right for them. A careful investigation into such cases will usually show that the person and/or the clinician did not follow the Standards of Care.
Genital reassignment surgery and even hormone therapy are serious procedures which must be used cautiously. Side effects are many and some are irreversible. While there are always ways to circumvent the Standards of Care, to do so exposes the person to unnecessary risks Experience of many transsexuals has validated this conservative approach to be the safest.

(ATEC) -- Dr. John Ronald Brown of Chuia Vista has been found guilty in San Diego of four counts of practicing medicine without a license. He was sentenced to three years in prison and ordered to pay $\$ 10,000$ to a 30-year-old Orange County transsexual tue to gross negligence.
Brown has performed over 500 gender reassignment surgeries in his 40 years of practice. He is well known in the gender community but has always been the subject of much controversy, with some of his former patients swearing by him... and others swearing at h1m.
Brown's license was revoked in 1977 beeause of gross negligence, and he was unsuccessful in $a 1983$ bid to regain it. In 1985 he was convicted in San Francisco of practicing without a license for performing the same kind of operations, and was at that time ordered not to continue. Since that time, Brown has been practicing in Mexico.

## IMPERIAL COURT BEGINS XIX REIGN

## ROLE MODELS

Julian Bond hosts a show called "ABF" which deals with lssues of the Black community of this country. I was flipping through the channels when I stopped to watch this show. They (Mr. Bond and his guests) were discussing the reasons that the prison population is so disproportionately black compared to the general population. In large part the cause was due to a lack of positive role models for young black men, or perhaps I should say boys (not intended in the pejorative) This got me thinking about our community. What role models do we have? Who was the first person you remember that was openly crossdressed? The operative word here is 'openly'. I would have to say ... and whoever said hindsight is $20 / 20$ is crazy... the first person was Jim Bailey, the "illusionist". Most of us would probably have some similar answer, some professional female impersonator. If not Jim Bailey then perhaps Charles Pierce. Who, specifically, is not terribly important, it is what they do that bears significance.
But, wait a minute, these role models are men. We know that, they make a point of letting us know. It's part of their act.
Who are our positive role models?
Virginia Prince? Merissa Sherrill Lynn? Christine Jorgensen? Renee Richards? Sheila Kirk?
Why not Mariette Pathy Allen? Gloria Steinem? Morgan Fairchild? Elizabeth Taylor? Sandra Day O'Connor? My role models, Anne's role models, have always been women. لow, don't get me wrong, there are members of out community that I admire for having the courage to be openly what they are, and "damn the torpedoes". But it is not the Anne part of me that admires them. Because we are dealing with something of a split identity, perhaps.it is appropriate that we have two sets of ideals. One set teaches us what women are, the other teaches us what we can do.
But.
It seems to me that many members of our community deal only with one set of role models. And depending on who you are talking about that set can be one or the other. Personally I find those without female role models distasteful, and those without male role models. disconnected from reality.
Do we use role models only for the superficial? Do we only care about women so we can copy how they dress

I also considered using the word "androgyne", but that doesn't do the job either, since it implies having gender characteristics that make it unclear whether the individual in question is male or female... and I definitely look like a girl these days!
I thought about, but discarded such complex phrases as "non-surgical transsexual" and "fuli-time
transvestite", since they don't reaily answer the question. Instead, the phrasing leads to a more complicated series of questions to more clearly. define what I am. I have concluded that there is a need for a new term to properly describe someone who lives full-time with a gender role opfosite to his or her physical sex.
I talked with Anne Blackwood about this neologic dilemma. She suggested a word, rooted in Latin (as "transvestite" 1s); "transvitae", translated as

# the bay of the bereuoman

Androgyny, from two Greek words meaning man (andro) and woman (gyne) was the earliest recorded term from a settled race for what we call today transgender. Even earlier nomads and tribalists had terms for it such as e La Ha (Coccopa Indian) and Heemahnah (Apachianata tribes), the term Berdaches presumed to be of either old French or Spanish origin and a slang term for whore, was applied by the Conquistadors on their meeting Native American transgendered.
There are as many ancient terms for vampires and werewolves. All the variants on shapechanging, be they tolfrom animal or across the gender borders can be found, in the roots of all the races and faiths of the world... where ever there is humanity the two kinds of shapechanger exist side by side.
Given which fact, it is not so unusual that they should share some characteristics and similarities, even overlay some of their method. Their histories touch each other closely, as they touch all things between them. Yet seldom is a comparison consciously undertaken.
We live now in a society which blinds itself to its own ignorances with a superficial sophism and technocratic mystique. In our so-called civilized world, minorities are feared and reviled more than ever before. Where once persecution had a blatant motive in superstitions, and punishment for difference was swift and emphatic, the fear of now is unstated and ignored in itself with the result, that difference is punished by isolation and within an illusory freeness to be, a genocidal suffocation by conveniently and of ten hypocritically elastic mores.
In democracy, another old Greek word which for its egalitarian suggestion, in probability, was inspired by the human dualism of androgyny, each individual has a right to opinion. But there is no onus put upon the individual to rationalize that opinion.
Most critics, be they of the modern human vampire, or of transgender will premise their critique with "I think..." which, for anybody needing to answer ought to be the core of the challenge, when the remainder of the critic's statement reveals that they don't think. At best, they grunt their way through a series of poorly coordinated brain motor functions index inned to a limited series of value judgements. But for being at the unfortunate end of this kind of "thought" dally, if only through a media centered on undermining all we belleve and hold dear, such minorities as ours are obliged every moment to think, and think deeply. In challenging our own cognition and monitoring our behavior patterns, we share (the vampire and the werewoman) a whole separate pantheism closer to that eclectic one beloved of ancestral tribal Shamans, and an awareness of the properties, uses and applications of time and space akin to Quantum theory.
The rampire seeks to live forever through death, the androgyne succeeds in living a natural span as a cyciical continuum, defying death and age, through ilfe 1tself.

A prepubescent child, despite what Freud liked to call polymorphous perversity or the nalve physical experimenting of an infant, is an asexual and looks. thinks and behaves in a dual fashion. No matter the haphazard experimentation of social science of late, an infant is an androgyne quite naturally. At the other end of the human scale of age, the post menopausal elderly achieve (or relearn) a methodical dualism of thought and action, a justice and wisdom, and also take on a dual look; many old men could be mistaken for old women and vice versa in their looks.
Only the middle aged suffer a frenetic urgency to identify themselves as one thing or another, only the middle years invented sexuality, and all the worst weaponry of the sex war.
These may be reasons why it is those beyond infancy and before elderly, who rape children, grannies, animals and each other while protesting their age groups' own actions, and who round on the transgendered and the vampire for, in their two different ways, transcending that hectic barrier of a midlife. They, while denying the dualism documented as native to all humans, and the majority of other species too, simultaneously envy it in others.
What was once penis envy, then vaginal envy, has become what in truth, it always was, androgyny envy. Everyone would like a holiday in someone else's body, and those who can construct it from their own mind, soul and body despite, and of ten because of the hardships others make for them for it, have acquired a sensual "je ne sais quoi" outshining that of ordinary mortal man or woman. both vampires and transgenderists can charm
anybody/thing, of any age or gender. As importantly, but less obviously accepted, both can remain aloof to the charms of others if they so choose. True independence in an illusory self deceiving world, is poorly rewarded.
In the seventies $I$ began to look into the depth and width of androgyny envy in society, beginning with the most obvious effect of the cause, murder. An extreme behavior which reveals in detail what happened in a mind, and because most murderers are caught and all are reviled, is seldom as readily denied by media and society.
After half a decade of collecting, collating and examining information on all types of murder, I was forced to accept (against a scientific integrity which feared it was too swift and easy a finding) that all murder is in some way originated by and related to a human terror of inner, personal polarity of gender ldentity (i.e., androgyny envy).
Looking at the mythic vampire, whose soul is not their own but in the keeping of the Christian's Devil, it would seem that by being the undead they have effectively abandoned the other self, and become a kind of monist. But escapism like that would be expected. once the myth became the property of a Judeo-Christian pantheism, in which there is good and evil and all people are thought to be born inately evil with

SOLVING A "HAIRY" PROBLEM
by Valerie Driscoll
Before you can achieve the best look possible with makeup, all facial hair should completely be removed. This may sometimes irritate the skin, especially when it is sensitive and you must shave really close. Try using a water soluble cleansing cream or gel and rinse with warm water. If you must shave often, and use an electric shaver, alternate between it and a manual razor. (Ed. Note: As recommended in the June "Odds \& Ends" column, the "Sensor" cartridge-type razor and "Edge with Lanolin" shave cream tend to give good results with little irritation.)
Some tips for a more effective and more comfortable shave with a manual razor
Keep your razor clean and wipe with rubbing alcohol before use. Also, allow your shaving cream or gel to soften the beard for about two minutes before you shave.
Start at the the cheeks and work your way down without stroking each area with your razor more than twice. Rinse with warm water, then with cold. (To help conserve water, fill the washbasin before you start and use that water supply for dampening the skin pre-shave cream and for clearing your razor during the shaving process. Then you won't feel so guilty using more water to rinse twice!)
Aftershaves tend to be loaded with perfumes. These irritate the skin, so use witch hazel or other mild astringent instead. Follow this with a moisturizer pat it on; rubbing is too harsh on the skin!
Use powdered alum or a mud mask to stop bleeding on small cuts. Be sure to use alcohol on your skin before using tweezers to pull out ingrown hairs!
(By the way, if you drive a lot or are otherwise out in the sun a lot during the day, a sunscreen is very important to keeping your face soft and healthy. Coopertone makes an excellent SPF 45 that is both waterproof and hypoallergenic.)
Remember, hair growth starts well below the surface layer of the skin so you may still have a dark shadow after shaving. Next month, I'll discuss how to conceal that shadow properly.

# THE GENOER COMMUNITY: A POLITICAL AND SOCIAL

(Part 3 of 10)

SCHISMS WITHIN THE COMMUNITY
Goals of the Nineties should include repairing, once and for all, the divisive schism of mistrust and discomfort that exists among several groups that have essentially the same overall political and social goals; goals of economic freedom and cholce of lifestyles. The three groups consist of the Gay community, the Cross Dressing community, and the Transsexual community. There has been an "uneasy alliance" that has traditionally existed between these groups. The TS resented the TV for not being as public with their desired expression of femininity and not experiencing the social ostracism and the job discrimination that a TS suffers, sometimes finding herself in a newly created economic "pink ghetto".
the other hand, strictly heterosexual TV groups have been somewhat exclusive and discriminatory towards Gays, Bisexuals, and suspicious of the $T S$ and $h 1 s$ or her needs in their newly acquired role of the opposite sex. The Gay community as a whole have felt that their tastes and goals were entirely different than that of the Gender community. After identifying gender preferences long ago and working hard to overcome society's unjust discrimination by coalescing political power in the Seventies and Eighties, Gays perhaps feel that the Gender community is not of their concern They have only recently worked out some divisive differences within their own community involving some opposing goals of Gay men and Gay women.
A major goal of the $90^{\prime}$ s should be: How to bring together the visible "T". community with the invisible "T" community. Walt Kelly's Pogo once said, "We have met the enemy and he is us". There are two major problems here, namely apathetic detachment and dogmatic infighting
There is a kind of malaise by many in this invisible community regarding Gender community involvement. The social crossdresser will go out for a weekend adventure in the safe haven of a social club, perhaps quietly resentful of the almost certain scorn of the general public, but too fearful or unconcerned to do anything to change those views. With this attitude so prevalent, the question I pose today is: Does the "Community" we so casually refer to even exist or is it merely wishful thinking on our part? Are we fust a collection of individuals focusing on our own selfish goals or do we have a larger altruistic agenda? Then of course there is the question of bringing together the visible community, with all its petty bickering and disruptive philosophic posturing. How can we hope to educate the general public as to who we really are with so much energy wasted on infighting among splinter groups? The public regards us with a good deal of suspicion based on archaic stereotypes promoted by media, mistrust, and misinformation. How will we reach great numbers of unhappy, isolated people making their own lonely discovery of true gender expression? Without access to support groups or knowledge of educated professionals, many are so consumed by guilt or shame they begin to consider suicide as a serious alternative, especially among

teenagers. In 1989, the U.S. Department of Health and Human Services task force on youth suicide estimated that Gay teenagers may comprise as much as $30 \%$ of the total number of youth suicides. I feel that gender related issues are of ten lumped in with this figure Don't we have an obligation to those people as well as ourselves?
The conflict that exists among various groups leads to lots of silly finger pointing in an "US vs THEM" attitude. IFGE is a solution for the 90 's in that it is trying to find a common ground among Gays, Crossdressers, and Transsexuals to present a united front on issues of mutual concern
One such example of polarizing and ideclogical semantic time wasters is the "label" game. One gender group has recently complained that IFGE couldn't speak for the transsexual because $1 t$ was run by, quote, "Male Crossdressers". This kind of short sighted ignorance overlooks a built-in irony in the community. "Male Crossdressers" will be visible a lot longer than transsexuals because it is the transsexual's main goal to be absorbed into society and disappear, of ten attempting to erase all previous history.
In either case, we need to help each other and it is precisely this kind of dissention that impedes helping others in coming out. Who is there to help and offer peer group support? Outside of the need for the professional counseling community, there is also a need in the $90^{\prime}$ s to address issues related to the legal rights of the community and to work to erase a public stigma concerning this particular "mode of expression" Ve should expect that most post-op TS's will eventually disappear from our ranks because of their intended

One of the best publications (and probably the first) in the history of the transgendered community was Virginia Prince's "Transvestia". Back issues of this ploneering magazine are prized possessions for many, and their contents are so timeless that they are rereadable indefinitely. Sandy Thomas has obtained the copyrights to all 100 1ssues, and plans to create a new fiction series by reprinting stories from the older 1ssues. Along with the copyrights came hundreds of back issues of the original magazines, which Sandy is selling for $\$ 7.00$ an issue ( 5 for $\$ 30.00$ ), plus $\$ 1.00$ per book shipping (up to a $\$ 4.00$ maximum). The issues she has available are \#78, 79, 88 through 93, and 95 through 98. She suggests listing second choices when ordering as supplies of some issues are limited. Sandy has also acquired the copyrights to the old Transvestia/Chevalier fiction series, and is in the process of retypesetting the stories for eventual republication.

## CONSIDERING"A WIFE'S ACCEPTANCE

Although this is a personal commentary, and not research based, I present it in the hopes of gathering comments and ideas from other wives and couples.
What is it that can make a wife who has felt accepting and positive about the influence of crossdressing on her husband, move to the point of a negative attitude? I am an educated person with a background in sexuality issues, family problems and counselling. My husband's expression of his crossdressing was initially seen as positive to his self-esteem and to our relationship. It was hoped that sharing of intimate feelings and open communication would strengthen our relationship, and it did at first.
It is true that I did not have all positive feelings and my husband in his "femme" persona did take some getting used to. I came to feel comfortable being with Robyn and to grow to love her as I loved my husband. This was the start of a relationship with my "best girl friend". I enjoyed shopping for her and seeing her joy at trying on feminine apparel. I get a kick out of sharing items from my wardrobe with her. I welcomed her into my bed at $t 1 m e s$ and found her a source of nurturing and comfort at $t$ imes.
This may all sound like a crossdresser's dream. What then soured my feelings? Slowly, and at times not so slowly, this girlfriend that invited into my life took over. She wanted to do my cooking, mother my children and even share my role in bed. Hanging in my husband's closet are Robyn's clothes and his male clothes; in my closet are only female clothing. I do not have another identity or role to play. My best friend not only wants to share my life, but to take over my roles, clothing and my husband. You might occasionally really enjoy sharing your home and family with a friend you love, but if she came in and took over what you saw as your roles and rights, would you feel like inviting her back?
A person whose self-1dentity is threatened is bound to feel negative. My expression of this negativity is seen as a threat to my husband's crossdressing and his self identity. This closes off the paths of good communication. So the problem of self identity is driving us apart... not leading us into a more open and intimate relationship. It is very difficult to get out of this spiral. Since we both feel threatened, this leads to a kind of verbal shoving match.
I wonder how other wives feel about this. Is there room for expression of the husband's feminine side and for the wife to retain her identity as the primary woman in the marriage?
[ Note: While this article was being scanned, Cynthia Howard's wife, Toni, took the opportunity to read it and had her own comments to share:]

No, there isn't. Not unless the crossdresser is very carefil to acknowledge the wife's role as the primary woman and then to follow through in actions to prove that that is how he percelves her. Sadly, that rarely happens... I would dare suggest that's a damn cold day in hell when it occurs. And if you wonder why wives

## GENDER ALTERNATIUES LEAGUE GNNOUNCES FORMATION

(kmr) -- Claiming that the gender community is "ready for a change". Cynthia Howard has announced the formation of a new organization to be called the jender Alternatives League (GAL)
GAL's main purpose, according to Howard, will be to promote freedom of gender expression. She proposes to do this through educational and political activism, and to try to bring all members of the community together, regardless of labels or lifestyle differences. GAL also intends to join forces with any other groups trying to achieve the same or similar goals.
GAL's first announced project will be to remove the labels of "mental illness" and "abnormal" from the DSM-III-R and other medical references. Howard maintains it is the resultant stigma that caused the exclusion of transgenderism from protection under recent civil rights legislation. After publication of a lengthy editorial in the Tri-Ese national magazine "Femme Mirror", Howard says she has started to receive letters of support and monetary contributions from the community. She has called for a member of each transgendered organization to become a part of GAL's board of directors.

## GENDER QUESTION OUERSHADOUS UEST HOLLYUOOD ASSEMBLY RACE

("Renaissance News") -- Is Elizabeth Michael, a candidate for the Republican nomination for the 45 th State Assembly District, a woman, a transsexual, or a transvestite?
That's the transgender mystery facing officials in West Hollywood, with both Bob Davis, her GOP opponent, and Tom Larkin, co-chair of the Lesbian and Gay Republican Task Force claiming that Michael is ... or at least was
a man. Larkin charges that Michael "was born Alan Michael, later becoming Allania Elizabeth Michael and finally, Elizabeth Michael." He also says that in the mid-1980's, Michael attended a local synagogue in drag. He's been quoted as caliling the candidate "a six-foot, four-inch transvestite."
"Basically, we're outing' her," Davis said, using the term that describes the practice of forcing gays and lesbians out of the closet. "She's a person who is definitely trying to harm gay people, who's got tisis (gender) condition and certainly took advantage of the right to do with one's body as one wishes."
Michael has refused to respond directly to the charges from Davis and Larkin. But she did say that she was sorry about the "gender-bashing attack" that is an attempt "to make sexuality an issue." She added that she supported "bread and butter" gay rights issues.

My view of crossdressing teeters between it being an artform... and being a crutch, with which a person may more comfortably express such personality elements as society considers appropriate only for the opposite gender. i concede that other motivations are possible: 1 just haven't found, as yet, a need to deal with them. While i love fantasies, 1 don't think it does our Community any favors to indiscriminately meld them into the realities with which we must deal. 1 perceive my mission... if such can be said to exist... to be that of pointing out where i think that such commingling has taken place.
My hope is for a world wherein everyone feels secure enough that no one need feel that they must hide a portion of their being out of fear of persecution. 1 seek to promote a social environment in which each person may appear and act as masculine or feminine, or any blend of the two, as they feel is appropriate for themsel ves.
May it quickly become so.
P.S. Ordinarily, the "late breaking news" blurb at the end of my August column would have been saved for an April issue. However, in view of the governmental maneuvering to lump us into the same classification as child molesters, rapists, and other sociopaths as exempt from the protections of the recently passed handicapped rights bill... added to the spate of attempts to restrict citizens' access to a variety of products, e.g. spray paints ... it seemed an appropriate opportunity for satire.
For the benefit of those who might have taken it at face value, let me backpedal a little; so far as we know... up to the time of this writing ... no one with any real authority in any state or Federal agency has made any serious proposal to regulate heel heights for women's shoes.
There is a serious side to this. The fact that

As : write this column, it is becoming obvious that this issue of "CrossTalk" will be arriving in your mailboxes late. There are several reasons why this has happened.

starting with the left pinkie across to the right.
5. Apply a moderate amount of Jonee to each fake nail, starting at the left and work across the left hand. (Reverse the order if you are left handed.) Of course, only apply the glue to where the nail will come into contact with your own. Then apply a lesser amount to your own nail in the same order. Allow to sit for about 5-7 minutes until the glue becomes tacky.
6. Now you are ready to apply the nails. Start with your left pinkie by picking up the nail by its tip and squarely place it on your own, holding it down with moderate pressure for about 5-10 seconds. Repeat this procedure until your left hand is complete. Now skip to the middle finger on your right hand and apply nails to the middle, ring and pinkie. NOW go back and appiy the index finger and thumb. This sequence allows you to handle the nails easily and not get glue all over your hands and everything else. Now doess't that look pretty! (Precautions: Don't apply your nalls before you are dressed. Pantyhose are tough on nalls and vice-versa; as are bras, and tight buttons. Don't get your nalls wet for at least 2 hours after application. If my hands need washing, I use a face cloth and wash them with that rather than submerging them in water. Don't apply hand lotion prior to applying your nails. Don't lift and try to re-apply if the nail doesn't fit squarely; start over with that particular na1l.)
7. This is probably one of the biggest advantages of Jonee. To remove, merely bend the nall back and forth to loosen the bond. After you remove each nail, and PRIOR to removing the next one, remove the glue with a round wooden toothpick by sticking the glue with the point and twist. The glue will cling to the toothpick and you can just wind it up onto the toothpick. Do this immediately after removing the nail from your finger as the glue loses its elasticity quite quickly when it comes into contact with the air. Use the glue that is on the toothpick to remove any residue that is left on your own nall. If all the glue doesn't come off the fake nalls, don't worry about it ... it will come off next time your wear the nalls with new glue.
The only place I know where to purchase this product is Sav-On Drugs; and 1t's not cheap (\$1.89 for a 0.8 oz tube) but it's worth it to me. I usually buy 4-6 tubes at a time
