here comes a time in the life of every organization when change becomes an imperative. IFGE is no exception. Though we are the most successful nonprofit in the transgender community, our growth over the years has embedded a variety of faults, some of which led to serious financial difficulties in late 1997. We are taking that as a serious warning sign, and have undertaken a program of serious review and rethinking of our organization. We are also listening carefully to criticisms from the community, and working to make needed corrections. Among the changes happening:

We've re-prioritized our handling of the monies that fund-raising, membership, and publication sales generate. Highest priority is given to you, our constituency. Whether it's an order, refund, or mistake correction, you get highest priority. Payroll comes second. It's your money, and our highest priority is to handle it responsibly.

Our bookstore is freshly stocked with a generous array of titles, and will continue to be, so that you can get the information you need now, not six months from now.

Our magazine is now published on a schedule, and will be on newsstands March 1, June 1, September 1, and December 1. We have a new distributor

who promises to double our circulation in a year's time. We'll believe it when we see it, but we have good reason to be optimistic.

The magazine is in the midst of a change of editors, and it remains to be seen where things will settle out. For now, Mykael Hawley and Nancy Nangeroni will be producing it.

Our web site is fresh, updated weekly. Though barely started, it has already received praise from around the community. If you have a browser, check it out at <www.ifge.org>.

We are entering new collaborative efforts with other organizations. We are cosponsoring a symposium on aging and transgenderism in New York, a TG health conference in Boston, and will be taking advantage of every opportunity to network with established GLBT aducational and activist organizations and publishers around the country.

Best of all, we are graced with generous donors who believe in us and in this community. We enjoy the services of a growing pool of volunteers who donate their time and energy, and a dedicated staff who work long hours at significant personal sacrifice. IFGE's work is about people, and we are taking a fresh new look at our work, starting here at home.

guess I will never understand some people. The latest controversy surrounding the Winslow Street Fund is a perfect example of out of control hysteria in the media.

The title line reads, "Rape on Winslow Street". What follows is a series of inaccurate facts, misleading assumptions, and opinionated statements. If this is true, why would someone write such and article you ask? Well let's investigate the chain of events that led to the call of "RAPE."

About six months ago, several Trustees of the WSF spoke with the IFGE board about a possible loan. The Trustees have the power to give grants or loan monies for any cause deemed worthy. Regardless of what some people "think", the history of the WSF demonstrates a pattern of both. For the Trustees to act, they need only a majority vote was already in place. The requested loan conditions did not get accomplished in the time frame they originally set. This person became upset, and demanded immediate action. With no quick results, and increasing aggravation, she decides to go public with the matter, even though this was an internal matter between the Trustees. I might add, the Trustees do make a pledge of confidentiality.

The Trustee's aggravation is dumped on a friend who writes periodically in national publications. Deciding this is newsworthy material, the "Rape" article is born.

I just can't understand why certain individuals are so hell-bent on trying to undermine any organization that is striving to the betterment of the Gender Community. The good news is, donations at IFGE actually saw an increase in the months after the article. For those of us who still spend may hours donating our time to organizations like IFGE, we appreciate your continuing support and the occasional pats on the back. We love you.

showing, or performance." At least two potential organizers have already come forward, and more are expected as the word gets out.

Asked why IFGE would sponsor such an event, Nancy answered, "The arts always lead society in critical thinking towards social reform. Transgender art has the potential to speak to gender issues in ways as yet unheard of, politically or organizationally. Moreover, there are many talented and artistic people in the TG community who could really benefit from promotion of their work. To help these people's voices be

heard is an important aspect of IFGE's charter, which is to promote freedom of gender expression, not just for those whose needs we know well, but also for those whose voices haven't been heard yet. Transgender art is a vehicle for raising awareness of voices otherwise lost in the noise. Support for transgender art is also a way of supporting a segment of our community which is, on average, less affluent."

**Bobbi Johnson** won a Star Trek Book


In addition, cash donation of about \$50 was given by generous partyers.

Ioan made to IFGE by the Winslow Street Fund committee. The Board gave trustees Laura Caldwell and Abby Saypen a vote of confidence for their actions, which helped the community by helping IFGE through a difficult period. "The purpose of the fund is to help the community, and we felt that IFGE's contribution to the community merited some support from the fund," said trustee chair Abby Saypen. "The possibility of a loan was discussed openly at the Board meeting in Atlanta, which was attended by individuals outside of IFGE. I'm gratified to have the support of the Board in acknowledging that we acted appropriately."

The Winslow Street Fund has an excellent record in making key grants to emerging organizations and supporting diverse elements in our community. However, misinterpretation or miscommunication about the exact relationship between the fund and IFGE has given rise to public acrimony surrounding the use of the fund to help IFGE. The board's action will hopefully be seen as wise, calling for clear documentation of the exact nature of the WSF and its relationship to the IFGE Board, so that all members of the community can have the same understanding of what the fund is and how it operates.



In her own words, "I feel that after three years, with the success of Transgender Tapestry's new format, our new distribution arrangement and the appointment of Rivendell, a major gay and lesbian agency, as our national advertising representative, I have accomplished most of the goals I set myself when I first accepted this position. I am very eager to move on and become involved with the struggle for transgender protections on the state and national level, which is not possible as long as I continued to work for IFGE. "

# IFGE TO EXHIBIT AT APA

### he International Foundation

for Gender Education has been confirmed as an exhibitor at the upcoming conference of the American Psychiatric Association in Toronto, May 31-June 3, 1998. The APA is the organization responsible for the Diagnostic and Statistical Manual of Mental Disorders, which is used by mental and medical health professionals and insurance companies to diagnose and justify treatments of persons with various mental disorders. This manual contains a listing for "Gender Identity Disorder" which has come under strong criticism from the transgender and GLB communities for its use to stigmatize and justify mistreatment of both children and adults who exhibit nonconforming gender behavior.

IFGE offers to share their booth space with other organizations who are interested in being part of the dialogue between the APA and the transgender community. IFGE exec Nancy Nangeroni stated, "For some years now, IFGE has been attending the APA conference and educating attendees about transgender issues. The people that we reach are those who will be providing therapeutic services to transgender people, and we believe that this advocacy effort is one of the more important services that IFGE provides for its constituency. This year, with the controversy raging over GID, it is especially important that IFGE be present at APA, and also that we allow for some diversity in the perspective that we present to attendees. Accordingly, we have invited GenderPAC to join us, and welcome inquiries from other groups who would like to participate."

## IFGE BOARD APPROVES MEMBERSHIP CHANGES

A

t the January meeting, the IFGE Board approved changes to IFGEs membership fees. Changes include both a new, reduced-fee membership category, "Student/ Limited Income," and a small increase to the basic membership fee. The new category will carry a reduced fee of \$20/yr for basic membership. Concurrent with that change, the basic membership rate will increase from \$25 to \$35.

Our aim is in making this change is threefold. We want to better serve the needs of those less fortunate than us, we want to encourage more participation from young people, and we want to increase overall income from membership without hurting anyone. By providing a category for those who can't afford an increase in their dues, with a "noquestions asked" policy, we're hoping to encourage more support for the organization while showing some sensitivity to the situation of a significant segment of our community.

Membership in IFGE includes a quarterly newsletter, 10% discount on bookstore purchases, and a 5% discount on convention attendance. It also includes voting rights in the election of members of the Board of Directors.

Many people underestimate the importance of the fact that our board is elected, not appointed. All it takes to put someone on our board is a relatively small effort. It's surprising to some members of the Board that more groups out there haven't taken advantage of this possibility. It's a great opportunity to influence the making of IFGE policy, and to leverage personal effort to make a significant contribution to the community.

In the past, bookstore receipts were used to help meet IFGE's weekly payroll needs, draining the bookstore moneys needed to restock inventory. The new policy will put further pressure on IFGE's fundraising effort, but new **Executive Director Nancy** Nangeroni says, "We've got to discipline ourselves to follow the best possible business practice. We can't take money from the bookstore to make up for lack of adequate fundraising effort. If we can't make payroll, that's my problem, not the bookstore's."

# IFGE SIGNS ON NEW DISTRIBUTOR

n an important step for Transgender Tapestry Magazine, IFGE has signed an exclusive distribution agreement with Deyco Magazine and Book Distributors, based in Plainview, NY. Deyco will assume responsibility for Transgender Tapestry's entire circulation to bookstores, magazine stands, and other distributors, with a few minor exceptions. "This is a good step for both IFGE and our community, because it will enable us to put the magazine into more bookstores and onto more newsstands. Right now, the magazine is too hard to find, and those who need it most too often cannot find it. Devco wants to offer a transgender publication as part of their catalog of publications, and they are excited about increasing our circulation," says IFGE exec.dir. Nancy Nangeroni.

"Moreover, IFGE has little available expertise that we can put into improving our distribution, while Deyco is expert at it. This partnership will allow IFGE to focus on what we're good at, which is content, and Deyco will worry about getting it out there."

The agreement came about following the bankruptcy of one of IFGE's largest distributors, Fine Print, who had accounted for a quarter of *Transgender* retail sales. Deyco promises to replace the lost circulation, and much more.

IFGE will retain responsibility for getting copies of the magazine to clubs and one or two businesses in the Boston area.

Deyco, founded in 1981, delivers over 750 magazine titles to over 300 specialty and secondary distributors reaching a total of over 50,000 retail outlets, the most extensive customer base of any specialty magazine distributor. They guarantee payment of all specialty and secondary distributor accounts, and work directly with IFGE's printer Cummings to ship direct from the printer, minimizing handling and shipping costs. Because they handle all invoicing and accounting, IFGE's business manager Nancy Cain will be freed from those tasks. "This will let me focus on other areas of IFGE's business which need my attention," says Nancy.

Editor Jean Marie Stine, drawing on her extensive experience in the publishing industry to contact other professionals for their assessment of Deyco's reputation, says "Everyone I talked to had nothing but praise for them. They are a first class outfit, and we're fortunate to sign them on as business partners."
