CHI'S OCTOBER MEETING

Since our Chapter President, Deanna, was not able to be with us during the evening, our meeting was conducted by our Vice-President, Karen. She opened the meeting by welcoming everyone, particularly our honored guest and National President, Carol Beecroft. Karen announced that the next Chapter social evening would be November 11th, at the Lite Factory; although this is not an "official" gathering, all Chapter members and our Chapter friends are invited to spend the evening together. Karen also reminded everyone that Christmas is approaching, and we would be receptive to an invitation from one of our members (who has a reasonably large home) to be our Hostess for the December meeting. Anyone who would care to volunteer please contact Deanna as soon as possible. Completing the business portion of the meeting. Upon completion of the introductions the meeting was turned over to Carol Beecroft for any remarks that she would care to make to the membership.

Carol told us she was most happy to be able to be with us again, and pleased to see the activity and growth of CHI Chapter. She advised that at the recent Tri-Ess Convention in San Francisco, the consensus was to return to New Orleans for the next convention in March of 1982. However, as in San Francisco, this time we will go "first class" in hotel, restaurants, and activities. Due to some last-minute problem and changes, the last Convention that was held in New Orleans was not of the best. However, that is not expected to happen again and Carol asked that everyone reserve late March of next year for the Convention, and plan to attend.

Carol indicated that the Femme Mirror is "next in line" for publication, and that she expected to maintain a regular bi-monthly schedule in the future for the national newsletter. Following the Femme Mirror, the membership Directory is scheduled to go to the printer in mid-November, with mailing shortly thereafter. Since a number of our members had expressed a concern about non-receipt of the Directory, we were asked whether we would like to have it completed ahead of the newsletter. After a brief discussion of the question a vote was taken, and a clear majority agreed with the original schedule of the newsletter first, then the Directory following.

Carol advised those present of changes that were being made in the organizational structure of Tri-Ess for over-all improvement, and the general reasons for them. (Since these matters will be formally announced in the next Femme Mirror, they will not be reported here). As with any group or organization, certain adjustments must be periodically made to keep us abreast of the changing times.

Although Carol did not mention it in her remarks, Donna raised a subject that has been discussed among individual members as well as at CHI meetings: Carol needs some help (of the secretarial type) since she is being "spread thin" with so many responsibilities. The point was made that our national dues have not been increased for many, many years even though inflation is taking its toll. Also, our Sorority is engaged in a national advertising program, has a need for our national Officers to regularly travel to organize and support our Chapters, (Cont.)

and has other expenses not even thought about when our current dues structure was established. The members present were asked if they would support a reasonable annual dues increase to help off-set inflation (everything else is going up; gasoline is no longer 35¢ a gallon), possibly help to secure some part-time office assistance, and allow greater organizational efforts. Since no one in the Sorority receives any remuneration (except a \$100.00/month travel allowance recently granted to Carol for her work with Chapters), and in fact many expenses are paid for by our Leaders "out-of-pocket," any increase in annual dues will be used 100% for the work of the Sorority. Based upon these facts, CHI Chapter went on record as strongly supporting a reasonable increase in the annual dues for Tri-Ess.

Our thanks to Carol for being able to be with us. We benefited from her general comments, and we trust that she received input from the comments of our membership both during the formal Chapter meeting, and during the social period afterwards.

Some of our members who have been assigned the new "ZIP+4" nine-digit numbers have been submitting changes of address to the Chapter reflecting the four-digit addition to their present ZIP code. Congress has delayed implementation of the program until October, 1983. Thus, CHI Chapter will not be using the new ZIP codes on our mailing list until such time as the final details of the program are worked out and approved by Congress. At that time we will request address corrections from all of our members, and begin using the new ZIP code system. 
CHI'S NOVEMBER MEETING
