



A FOND FAREWELL AND HOPE FOR THE FUTURE





ne year ago, IFGE was in trouble, and I stepped forward. I volunteered my services not so much because I wanted the job of executive director, but because I thought I could help, and I could not refuse that help to an organization which was in some measure responsible for the salvation of myself and many others.

I knew when I took the job that I was grabbing a tiger by the tail, a tiger that would likely shake me loose and feast on my sorry carcass. I also knew that my approach to the job would not be looked upon favorably by all. I knew that my politics are too radical and my sensibilities too feminist for some. But I took the job anyway, because the other alternative I heard being discussed was to close the doors.

Over the past year, we at IFGE, and I mean we, because it has been a team effort of the entire staff, have made some significant progress.

We've revitalized the magazine, which is the single most important product of IFGE. It now carries work by the very best writers in our community, and the information content has nearly doubled, making it a much better value for our readers. We now address an audience that includes much more of the diversity of the trans community, with more meaningful stories and articles. We made it through the difficult transition to a new distributor, reducing our office workload while improving our potential circulation to respectable outlets accessible to more people. We brought on exciting new editorial talent and put to rest the persistent complaints about editorial communication problems. And yes, we took some chances, and made some mistakes.

We wired the IFGE office with a network connecting computers to each other and to the

Internet, bringing the entire staff closer to the online community that we serve, making us more accessible -- and responsible -- to our peers. We created an exciting new web site that provides useful resources, news, information, and contact with IFGE. We provided a mechanism for subscribing and making donations on-line that provides a new level of convenience for our members and subscribers while paying for the entire web site many times over. Our on-line bookstore is the most complete and informative on the subject of transgenderism anywhere.

We also reorganized the bookstore somewhat, giving it responsibility for its own accounting and inventory management. Thanks to a generous donor, the bookstore is the most well-stocked and titled on the subject, and continues to enjoy the services of a dedicated and well-liked manager.

We also increased magazine advertising revenue by about 50%, thanks to a new advertising. We brought in our first-ever grant, \$11,000 from the Gill Foundation in Colorado Springs, an organization primarily chartered to give to Gay and Lesbian oriented organizations. This was their first grant to a trans cause, and the first grant made to any national trans education organization. Thanks to assistance from the Windslow Street fund we've been able to responsibly manage our debt load. And for the first time ever, we made medical insurance directly available for our staff.

I know that there are some things that we've done that have come under criticism. We dared to put Leslie Feinberg, the founder of the modern transgender liberation movement, on the cover of our magazine instead of another pretty face. We dared, in hopes of increasing our reach onto more mainstream newsstands, to remove the personals from the body of the magazine. We dared to

I believe that I can be a more effective force for our community in an independent role than I could be at the helm of IFGE.

It has been my pleasure to serve our community. I share the disappointment of those who wish I could have done more, or better, or differently. But I know that together, we stood, and continue to stand, for the principles upon which IFGE was founded: respect for and inclusion of all diversity, and commitment to making this world a better place for all.

SEA LIFE CHANGING SEX

'Gender bender' chemicals are impairing otters' fertility



nvironmental campaigners say chemicals that interfere with the hormone system are causing increasing damage in the rivers and coastal waters of Britain.

The chemicals are known as endocrine disrupters (EDCs), or "gender benders". They include some pesticides, dioxins (which can be given off by incinerators), and many other synthetic substances. These EDCs mimic natural hormones, the body's chemical messengers, or block the cells that act as hormone receptors.

The campaigners say the effects of EDCs are now known to be damaging the endocrine systems of fish in the estuaries of the Mersey, the Tees and the Tyne. In the Thames estuary and other major British rivers, they say they have found flounders which

have become feminized. Other species affected include female dogwhelps in North Sea shipping lanes and close to main ports, which are developing penises. Both common and gray seals have been found with suppressed immune systems. And otters are suffering from lower fertility and reduced penis size.

The campaign groups which have sounded the alarm are Friends of the Earth, Greenpeace, the Marine Conservation Society, the Whale and Dolphin Conservation Society, and the World Wide Fund for Nature.

Most chemicals' effects are unclear. They say that little is known on the toxicity of about 100,000 chemicals currently available for use. And they say this means "a global-scale experiment is being conducted where humans and the environment are being exposed to unpredictable cocktails of chemicals".

EDCs are among the chemicals which concentrate in body fat, and their effect becomes more marked as they move up the food chain. So someone who eats a lot of fish could expect to be absorbing EDCs in their diet. Like many other chemicals, their effects tend to be more severe in children. And one EDC may work with another chemical to produce an effect that neither could achieve in isolation. Although scientists have identified only about 100 chemicals as EDCs, the groups say these are believed to be just the tip of the iceberg.

They want industry to take responsibility for eliminating the threat of EDCs in the marine environment, and to make the transition to clean production of safer chemicals. And they say the government should act on the precautionary principle, refusing to allow chemicals to be discharged unless they have been proven to be safe beyond reasonable doubt.

AMERICAN AIRLINES IS BEING BOMBARDED BY HOMOPHOBIC AND HATEFUL CALLERS



merican Airlines is a major sponsor to and supporter of groups like GLAAD, the Human Rights Campaign, the Gay and Lesbian Victory Fund, the AIDS Action Foundation, DIFFA, AmFAR, and scores of community-based groups representing gays and lesbians. It is also the first airline to adopt a written non-discrimination policy covering sexual and gender orientation in its employment practices.

In an unusual joint letter released to the media on Oct.14th from the Family Research Council, Concerned Women of America, American Family Association and Coral Ridge Ministries, American Airlines was openly criticized about their policy. Radical right leader Beverly LaHaye also went on a Christian "talk radio" to blast American Airlines because "American's sponsorship of homosexual 'pride' events constitutes "an open endorsement of promiscuous homosexuality." She and the other groups have written Bob Crandall at American to complain that the airline

has "gone beyond mere tolerance" of gays and lesbians.

It has come to the attention of the our community that American Airline's switchboard and e-mails are being bombarded now by homophobic and hateful callers who have been urged by LaHaye and others to DEMAND the company terminate its gay/transfriendly policies.

American Airlines won the 1996 Diversity Award from IFGE because of their policy. Drop them a line and let them know that you applaud their efforts and support them.

HELP US TO HELP YOU

R

ecently, I have had some conversations with the president of the GLBT employee resource group (ERG) to which I belong and am active. At his request, I gave him contact information for a well-known transgender organization that is a 501(c)3 corporation. The ERG president mentioned the desire to have someone from the FRG "on site" at beneficiaries of our corporate giving, to be sure that the funds were well-spent. The remark prompted me to mention to him that trans organizations today are where GLB organizations were in the sixties and seventies; fighting for survival. The remark was well-received. and may lead to some additional fundraising activities.

But I don't want to leave that remark there. It doesn't have to be this way: these organizations need not be fighting for their survival. I'm often amazed at how many transgenders I meet who "happen" to work with computers or in some other hightech field. This is a field that does not pay poorly! There is a lot of money

in the transgender community, and our social service organizations can do a much better job of serving us if they're moved beyond mere "fighting for survival."

I give to my favorite organization through my United Way contributions --which my company matches. My company also provides financial contributions which "match" employees' volunteer activities at registered 501(c)3 corporations, and I've availed myself of that means of helping out, as well. Many corporations have matching gift programs for employees who make contributions to 501(c)3 educational organizations. Restrictions vary from employer to employer, but these restrictions are always on the nature of the educational services provided, never on the nature of the community served.

I know that the company I work for isn't the only company that has such programs. Really, such programs have nothing to do with ideology or "doing the right thing." Simply put, it's good

business. Corporate giving is a form of marketing.

Making a move like this takes a fair amount of courage. But it doesn't demand that you "out" yourself. If you're closeted, you need not leave that closet in order to get your employer to help out financially. Most of the time, the employers don't notice the nature of the organization. And should they recognize that you're donating to a transgender social service organization, that doesn't mean that 'you' are transgender. It means only that you recognize that rightfully this is a worthy cause.

I encourage all GAIN readers who work for companies that have employee-directed giving programs to avail themselves of those programs in order to help out our struggling transgender education organizations. And in the meantime, pass this little missive along to your friends. Together, we can help our transgender education organizations help us!

CALIFORNIA CHURCH INSTALLS TG WOMAN AS PASTOR

etropolitan Community Church (M.C.C.) of the New Vision in Walnut Creek, California will celebrate the installation of Reverend Vicky Kolakowski as the new pastor during a special Sunday service on November 15. The outgoing pastor, Reverend Jack Isbell, will preside over the ceremony.

The church, formerly named Diablo Valley M.C.C., is a congregation of the Universal Fellowship of Metropolitan Community Churches. The denomination was founded in 1968 by the Reverend Troy Perry as a ministry welcoming all people, but with a special outreach to the gay, lesbian, bisexual and transgender communities. The U.F.M.C.C. has over 300 churches in sixteen countries, including several in the Bay area.

Kolakowski is the first lesbian to pastor the central Contra Costa County church, and will become one of only two openly transgender senior pastors in the denomination. "I am very excited by the opportunities we have at M.C.C. of the New Vision." Kolakowski said. "There are so many people who haven't heard that God loves them unconditionally, and of the power of that love to transform lives."

Kolakowski received her Master of Divinity from the Pacific School of Religion in Berkeley in 1997. She holds also graduate degrees in law, public administration and engineering. She practices law and is a frequent contributing writer for the Bay Area Reporter, a weekly gay newspaper in San Francisco.

Named an Outstanding Woman of Berkeley in 1995, Kolakowski coauthored Berkeley's domestic partner public registry and chaired Berkeley's city commission that both oversees civil rights efforts and recommends outside social services contracts to benefit the poor.

The author of several scholarly essays on gay, lesbian, bisexual and transgender religious issues, Kolakowski has a passion for developing positive images and stories for these communities, especially from biblical sources.

"The Bible has been used for too long to long as a weapon to inflict pain, rather than a balm to support wholeness and healing," Kolakowski noted. "The Gospel, the good news, is that God loves us, and not the lie that God finds us unworthy and unacceptable."

THE MEDIA'S TROUBLE WITH TRANS

ournalists have a hard time dealing with the issue of transsexuality. But that is no excuse for demeaning the memory of the victim of a brutal and senseless murder:

Rita Hester, a 34-year-old transsexual who resided in Boston's Allston neighborhood and whose legal name was William, was stabbed more than 20 times during the Nov. attack.

That was the first crime. The second crime was the way the local media handled coverage of this heinous act.

The Boston Globe was the worst offender in the mainstream press. With the headline "Stabbing victim a mystery to many," writer Daniel Vasquez seemed more concerned with the victim's gender identity - and the neighbors reaction to it -than the murder itself.

The Globe story also paints a picture of someone who led an "apparent double life," someone who angered neighbors with "late-night loud music," a "nightclub singer and a

party-thrower." Hester is shown as someone who is not worthy of sympathy, someone whose life, perhaps, was not worth more than a curious peek - as a freak to be easily dismissed.

How sickening that the Globe would sink to such a journalistic low. While the Boston Herald did better, much better in fact, its two stories should not go unchallenged.

In fact, the Herald seemed to show its struggle with language. In its Nov. 28 story, the headline refers to Hester as a "transvestite." The following day's headline calls Hester a "transgender" murder victim.

To its credit, the Herald quotes Matthew Carlos, editor of the magazine Transgender Tapestry, explaining the difference between transsexual, transgender, cross-dresser and transvestite. A lesson we in the media direly need.

The Herald also talks to friends and acquaintances in order to paint Hester as a real person, not the freak show that the Globe portrayed. Concentrating on the fact that Hester was a "call girl," however, makes us question some of the Herald's sincerity.

And although we as a community haven't reconciled the inclusion of transgendered people in our civil rights movement, we at least expect more understanding and better coverage from the gay and lesbian press.

In the case of the Hester murder, however, that hasn't necessarily been the case. We were particularly stunned by the decision of Bay Windows, a gay and lesbian weekly serving the Boston area, to constantly refer to Hester as "Rita," quotes and all. In most news accounts, crime victims are referred to simply by their last names.

To see a gay newspaper playing petty word games with someone's name and, therefore, denying that person's identity, even in the aftermath of their death, is startling.

Not that IN Newsweekly is above criticism. We avoided the pronoun issue - whether to refer to Hester as "he" or "she" - by attempting to avoid pronouns altogether in last week's story. We also used a clunky construction in the first paragraph identifying the victim as William/Rita Hester.

We here at IN Newsweekly, as well as other news outlets, are still in the process of being educated on these issues. Over time, these issues will be resolved. After all, it's not that long ago that newspapers referred to gay people as "avowed homosexuals."

But journalists need to be willing to be educated. In the meantime, ignorance is no excuse for insulting a community and the memory of one of its members.



IFGE ANNUAL REPORT FOR 1997

Audited THE YEAR IN REVIEW



Our revenue pie chart this year is broken into seven parts. Transgender Tapestry magazine and the bookstore account for 45% of our revenue stream; membership and contributions - 32%; IFGE Convention -14%; Winslow Street - 4%; and 5% in miscellaneous income.

Our expense pie chart is broken into six parts. Salaries, the cost to produce the magazine, and purchase publications/books make up 54% of our total expenses; office administration and building expenses account for 26%; IFGE Convention - 12%; and 8% in miscellaneous expenses. (*Misc. expenses are mostly due to the expensing of our obsolete magazine inventory.)

A separate annual report for the Winslow Street is available upon request.

KEY EVENTS - HIGHLIGHTS

In January, we started using the Peachtree Accounting system. The data from this system was the basis for our first annual audit, which was completed by the summer of 1998.

In March, in conjunction with California Dreamin', we had a successful convention at the Queen Mary, in Long Beach, California.

In September, we moved to our new headquarters, 14 Felton Street in Waltham Massachusetts. We reduced our overall space by approximately one third, and reduced our rent and utility expenses by almost one half.

Nancy Nangeroni came on board as the executive director of IFGE in November. She set up the website, instituted organizational changes for the better, and aggressively solicited much needed donations.

In December, the Winslow Street Fund made a loan to the IFGE general fund of \$15,000, which has since been paid off in full with interest, and ahead of schedule.

We also had a very generous donor who helped us out during a difficult time, with a donation for the bookstore, and a loan which has since been paid off.

ach year IFGE members (you!) have the opportunity to nominate individuals for the IFGE Board of Directors. Through nominating and voting for qualified individuals who you feel best represent your constituency, perspective and desires for IFGE's present and future course, you have the ability to directly influence your organization's policy, as well as the services it provides to the TG community.

Board members are elected to threeyear terms. They serve without compensation. The Board oversees and directs IFGE affairs. It establishes policy and provides for overall operation and management of the organization.

Board members may serve as chairpersons of IFGE's action committees, including Finance, Fundraising, Nominations, Awards, Publications, and Programs & Conventions committees.

IFGE holds four board meetings each year at different TG events around the country. IFGE board members must

attend a minimum of two of these board meetings each year at their own expense. When considering potential nominees, please review whether they meet the following qualifications:

- Experience and/or competency in managing the policies of a growing, charitable organization.
- Commitment to the welfare of and service to the transgender community without consideration for personal gain.
- Pro-diversity attitude and commitment to serving the community without bias.
- Willingness to learn, sufficient self awareness to recognize and avoid personal agendas.
- Ability to exercise patience and diplomacy in the forging of consensus.

The person you nominate should be someone you know well enough to endorse their ability to work constructively within IFGE. Once you have determined whom you wish to nominate:

- Send a letter of nomination to the IFGE Nominations Committee at the address below.
- 2) State why you feel they are qualified.
- 3) Include information on how we can contact the nominee.

Nominations without contact information will not be eligible for inclusion on the ballot. Remember, individuals who represent your views and interests can't be elected to next year's board if you don't nominate them.

TRANSGENDERS AT RISK FOR HIV

n a report titled "HIV Prevention and Health Service Needs of the Transgender Community in San Francisco," by Kristen Clements, MPH, Kerrily Kitano, PhkD, Willy Wilkinson, and Rani Marx, PhD MPH, transgender individuals are found to be at a high risk for acquiring HIV. The report includes a study conducted from June 24 to August 8, 1996, in San Francisco.

According to the report, a small study of transgender sex workers in Atlanta found that 68% tested positive for HIV, 81% had contracted syphilis, and 80% had contracted hepatitis B. The prevalence of HIV infection was much higher than among non-transgender sex workers in the same neighborhoods. Another study found that 15% of all transgender individuals seeking hormone therapy at a San Francisco public health clinic tested HIV positive. According to the report, earlier qualitative studies cited in the report "identify psychosocial factors, such as low

socioeconomic status, social isolation, and low self esteem, that are probably associated with risk taking behaviors."

The 1996 study found that "economic necessity, as a result of severe employment and housing discrimination, results in a reliance on sex work to secure food, shelter, and money for many MTF individuals." The study findings also supported previous research that identified a cyclic pattern to sex work and drug use, and that this pattern is difficult to break. Once in this pattern, the high rates of drug use and unsafe sexual practices with multiple sexual partners puts this population at increased risk for HIV infection:

In addition, the report found that transmen and transwomen who do not engage in sex work also are at increased risk for acquiring HIV. According to the report, injection and non-injection drug use is "very common," and many transpeople "engage in unprotected sex because it makes them feel sexually validated [sic] and increases their self-esteem."

Ms. Clements notes that the paper described here "will be published in a special issue on HIV in an electronic journal called The International Journal on Transgenderism (http:// www.symposion.com/ijt)" in the next few months, or people can contact her at the email address given above.

In addition, the researchers of the above study recently have completed a "quantitative study of HIV infection and risk behaviors with 523 transgendered persons in San Francisco (both MTF and FTM)." While a paper has not yet been published, GAIN readers may obtain copies of the results that have been released by contacting Ms. Clements at the address above.
