Crossdressers have three basic problems in shopping:

- 1. Sizes. We aren't built like women. Most of us have bigger sholders than hips. We can buy separates, but even jackets can be a bit odd if not taken in some. It's surprising how inexpensive it can be to have garments altered, so finding a good seamstress can be very useful. You can then buy outfits for your shoulders, and have then taken in at the waist and hips.
- 2. Try-On. Women spend lots of time looking at how various shapes and colors look on them, but unless we pass extremely well, or find a very unique store, we have to wait until we get home. Most stores have strict rules about women in the dressing rtooms and who can blame them?
- 3. Prices: For most TV's, investment dressing is silly. We don't need goo leather shoes that wear well, we need good looking props. GLASSES:

A <u>short face</u> can be made to look longer by a huge, round frame which sits high on the nose or a shallow, rectangular frame which does not exited to the bottom of the nose.




A round face will look thinner in a shallow, wide

CORPORATE CROSSDRESSING (Part 2)

The interrogation started with:

"Is it true that you correspond under an assumed name 'Jean Taylor' and have a Post Office box in town?

..Do you have homosexual tendencies?

.. How long has this activity been going on?

.. How many people know about this?

.. When and how did this behavior start?

At the time, about a year an a half ago, I though I was only having erotic fantasies and that there was nothing compulsive about my behavior. I promised the CEO and Marketing Manager in Europe that I would cease all activities and cancel all my ads. I really thought I could do it. I reasoned, with my deep religious upbringing and spiritual power, I could overcome or suppress these desires. I have tried before - burning all my pictures, destroying erotic lingerie, discarding books and correspondence collections and each time, for a while, managed to bottle my feelings up inside me. Well, of course, in time the feelings returned only to be stronger each time. I just could not deny my feminine self any longer. So, I decided that if management could not tolerate my personal life style, I would face the consequences and quit. Rumors spread to customers and dealers. I got mail from Europe and USA sent to my femme name but addressing my male persona-but leaving out the same of the sender. This drove me crazy at first but I quit wondering. A second meeting was called by the CEO realizing that 'Jean Taylor' was for real and wouldn't go away., I was told that my image and my authority was seriously impaired vis-a-vis my employees and that there might be some negative business fall-out due to my alternate life style. I was asked if I was prepared to address the employees in an open meeting and admit to my crossdressing. At least this way the people would know officially about my crossdressing and management could show that they know of it too, and still stood behind their US General Manager.

For me, it was an opportunity to face my employees and correct some misunderstandings they seem to have had about me. The CEO had great concern for me personally and of course, was concerned about the success of our subsidiary in the USA. When he knew that my wife was now aware of my transvestism and tolerated it, he showed much more tolerance and an unexpected understanding of my situation. I was to call the meeting for 4:00 pm in the conference room. Everybody wanted to know what the occasion was for the sudden appearance of the 'big chief.'

The first reason was to tell everybody that anonymous letters from a disgruntled employee could not destroy the confidence management had in their US operations manager. Indeed, the company was started by me from scratch and developed into a multi-million dollar business with a distribution network all over the USA and Canada. The second reason was to regain the trust of the employees as well as that of management in their man in the USA.

Third, was that my 'thing' was of a personal nature and had nothing to do with the business as along as was making an effort to keep Jean in the closet. Following the bosses' explanation concerning the story that had been circulating, he told everybody that management was standing with me. I then was asked to address the employees. I told them that this was the toughest thing I had ever faced in my life having to admit to my fellow workers of my fantasies, desires and actual dressing. I told them that I had wished that the person or persons that seemed to have been troubled would have come to me directly. I told them at crossdressing has nothing to do with homosexuality and that I never ever made sexual advances to any of my employees. If I had caused anyone any problems or mental stress at their job

because of my 'hobby' I regretted it very much. I offered to answer questions but was glad nobody took me up on it

Up to that point, my wife did not know that our bosses abroad knew of my crossdressing and that our employees were talking about it all day long behind my back. She just so happened to visit me in the office that very day the boss arrived. I was frightened about how she would react when she learned that the boss flew in because of my crossdressing and that all the employees knew and had even reported me to headquarters. How will she take it - what an embarrassment for her? I told her that the facts were out in the open - everybody knows and they have talked about me behind my back. The boss called a meeting and that I would be expected to confess openly. She felt like she wanted to die. She could not face the employees whom she all knew. My wife and I had another private discussion with the boss that helped her to get over her chagrin. Some weeks later the boss was back in the USA with his wife. When those two ladies got together, they talked about my crossdressing. Looking back over the past few months in my life, I can say that it was a very eventful period. I's especially glad that my imprudence forced me to come out of the closet. Otherwise it most likely would have taken years for me to reach this juncture. I'm still learning to understand my famine persona. I must give my wife a lot of credit for being so tolerant and helping me to understand her feelings.

Now I am very active in the community both here in the USA with CDI and in Europe. Hope to see you at the next CDI meeting and we can swap some stories.
